## River Area Council of Governments November 15, 2016

Chairman McIlroy called the meeting to order at 7:00pm, followed by the Pledge of Allegiance. Chairman McIlroy discussed changing the time of future meetings to 6:00pm. Members concurred.

Motion by P. Smith, seconded by R. Vary to approve the minutes of May 11, 2016 as presented. Ayes-7, Nays-0. Motion carried.

K. Amyot reviewed and summarized the circuit rider's report. Ms. Amyot presented a draft revision of the RACOG by-laws to include the V/Deferiet. B. Ferguson pointed out that with five (5) member communities that the Council would be comprised of ten (10) voting members therefore the number to achieve a quorum should be a minimum of seven (7) voting members.
