Minutes

The Champion Town Board met in regular session on Monday, December 3, 2001 at the Champion Municipal Building. Present were Supervisor Buckley, Councilmen Miller, Stewart, Watkins, and Buzzell, and Attorney Farley.

Supervisor Buckley called the meeting to order at 6:15PM. Motion by Mr. Stewart, seconded by Mr. Watkins to go into executive session to discuss labor negotiations. Ayes-5, Nays-0. Motion carried. Executive session began at 6:15PM.

Motion by Mr. Stewart, seconded by Mr. Buzzell to return to open session. Ayes-5, Nays-0. Motion carried. Open session resumed at 7:00PM.

Supervisor Buckley opened the floor for public comment. Mr. Roger Lancto questioned the public hearing process.

Monthly Reports

- Town Attorney Mr. Farley discussed major changes that he had identified in the Highway Maintenance contract, offered by Jefferson County, including indemnification and the lack of established standards for work performed by the Town on County roads. Mr. Farley recommended that the Board take no action on the contract as written. Motion by Mr. Watkins, seconded by Mr. Stewart that the Supervisor contact Mr. Burto, County Legislator, to make him aware of the Board's concerns and request his support at the County level. Ayes-5, Nays-0. Motion carried.
- DANC John Condino commented on an inspection by the NYS Department of Health at the Water District #2 water plant. No deficiencies were identified but improvements were suggested to heighten security including intrusion alarms, locks, mesh screens over inflows, new settings for chlorine residuals and the addition of wire to the top of the fencing. Mr. Condino reported that some costs may be FEMA reimbursable. Mr. Stewart suggested that security at the Great Bend master meter should also be reviewed.
- Highway Superintendent Mr. Sam Eddy, speaking in Mr. Martin's absence, reported that the measurement from the center of Cole Road to the guide rail is 22'1".
- Planning Board Mr. LaBarge requested that the Town Board set the second and fourth Tuesdays of the month as the meeting dates for Planning Board at the organizational meeting to accomodate Mr. Phelp's work schedule. Mr. LaBarge commented on the letter from the Planning Board which recommended no change in the present business district zoning pending development within the existing district.
