Minutes

The Town of Champion Town Board met in regular monthly session on Monday, January 7, 2008 at 7:00pm at the Town Municipal Office, 10 North Broad Street, West Carthage. Present were Supervisor Buckley, Councilmen Stewart, Watkins, Buzzell (7:05), and Peck (7:02), Attorney Farley, and Highway Superintendent Sech.

Supervisor Buckley called the meeting to order. Judge Karen Freeman swore in Councilman Stewart and Councilman Buzzell who were both re-elected during the last general election.

- Motion by Mr. Buzzell, seconded by Mr. Peck to establish rates for town water and sewer districts as presented. Ayes-5, Nays-0.
- Motion by Mr. Stewart, seconded by Mr. Watkins to re-adopt the investment and procurement policies and forms without amendment. Ayes-5. Nays-0. Motion carried.
- Motion by Mr. Peck, seconded by Mr. Stewart to set the first Monday of the month at 7:00PM as the meeting date and time of the Town Board; the second and fourth Tuesday of each month at 7:30PM, as necessary, as the Planning Board meeting date and time; and the first Wednesday of each month at 7:30PM, as necessary, as the Zoning Board of Appeals meeting date and time. Ayes-5, Nays-0. Motion carried.
- Motion by Mr. Peck, seconded by Mr. Stewart to designate Key Bank, Community Bank, HSBC Bank USA, Pathfinder and J P Morgan Chase as the depositories in which the Supervisor, Town Clerk, Tax Collector, and Justices shall deposit all monies coming into their hands by virtue of their offices. - Motion by Mr. Buzzell, seconded by Mr. Watkins authorizing officials to attend all necessary schools. Ayes-5, Nays-0. Motion carried.
- Motion by Mr. Buzzell, seconded by Mr. Stewart to set the mileage reimbursement rate in accordance with state reimbursement rates. Ayes-5, Nays-0. Motion carried.
- Motion by Mr. Peck, seconded by Mr. Stewart to designate the Carthage Republican Tribune as the official newspaper of the Town. Ayes-5, Nays-0. Motion carried.
- Motion by Mr. Buzzell, seconded by Mr. Peck to authorize the Supervisor and Deputy Supervisor to sign checks. Ayes-5, Nays-0. Motion carried.
- Motion by Mr. Watkins, seconded by Mr. Peck to designate Family Practice Associates as the firm to perform all necessary alcohol and substance testing. Ayes-5, Nays-0. Motion carried.

Public Forum

Terry Emerson, Great Bend, made remarks regarding valuation and taxation. Frank Koster, Carthage, read a letter dated December 28, 2007, which he received from the Town of Champion Board, concerning the Board's decision to appoint Stephen Eddy to the Town Planning Board. Mr. Koster disagreed with the Board appointment. He alleged that pertinent information is not shared with all Planning Board members and that the individual concerns of members regarding actionable applications are not considered. Eric and Amy Burke expressed support for Mr. Koster's complaint. Mrs. Burke questioned the Board's authority to appoint a new member prior to January 1, 2008. Attorney Farley confirmed that the Board acted within its authority to appoint a new member effective January 1, 2008. Mrs. Burke read passages, from a copy of the Town Law, relative to a Town Board's responsibilities and their duty to oversee the boards/committees that they appoint.

Monthly Reports

- DANC Bryon Perry requested authorization to replace the chlorine analyzer in WD#1 with the analyzer currently in service in WD#2 and to purchase a new analyzer for WD#2. Motion by Mr. Buzzell, seconded by Mr. Stewart to authorize the purchase of the HACH CL17 chlorine analyzer as recommended by the system operator. Ayes-5, Nays-0. Motion carried.
- Councilmen Mr. Peck inquired about whether action has been taken to remedy the zoning violation at Country Kitchen restaurant. The site is being utilized as an overflow lot for Caskinette Lofink. Supervisor Buckley responded that the Zoning Officer has contacted both the property owner and Caskinette's and that a Notice of Violation has been issued.
- Highway Superintendent Mr. Sech's written report was reviewed and accepted.
- Assessor Mr. Vargulick was present and invited interested citizens to attend state meetings on valuation.
- Planning Board Mr. LaBarge reported that the Board's first meeting of 2008 will be held on Tuesday, January 8th.
- Historian Mrs. Thornton invited the public to view the "Blizzard of 77" display in the office foyer.
- Circuit Rider Ms. Amyot reported that the RACOG recreation committee will hold their re-organizational meeting on January 9, 2008. The Chamber of Commerce and YMCA have expressed interest in participating in the committee process.
